PRODUCT: Aseptic Dark Sweet Cherry Puree Pouch

ITEM NUMBER: 31649

DESCRIPTION: Aseptic Dark Sweet Cherry Puree is prepared from ripened, washed and sorted dark sweet cherries (Bings,

Lamberts, Vans, etc.). The product contains no preservatives and no additives. Puree is processed through

a final finisher screen that is 0.033".

INGREDIENTS: Dark Sweet Cherries.

PROCESSING: Puree is pasteurized at 195°F or higher for a minimum of 20 seconds for commercial sterility. Puree is

cooled and aseptically packaged. Aseptic puree is guaranteed to comply with FDA, Juice HACCP: 21 CFR

Part 120, applicable state and local laws and regulations.

PHYSICAL PROPERTIES (physical properties vary due to seasonal variation of agricultural commodities):

Viscosity: 150 – 300cP with S02, 100RPM, 500mL Sample

EXPIRY AND STORAGE:

Product is shelf stable, no refrigeration is necessary for food safety of unopened bags.

Refrigeration is highly recommended for optimal color and flavor quality.

Shelf life is 18 months at ambient.

Refrigerate after opening.

Shake well prior to each use. After use, rinse spout gently with clean water.

Discard after 14 days of opening.
